4. The M.B.A. and / or M.C.A. Programme(s) under reference should be a part of the engineering college run by the management and not otherwise. In other words the above programme(s) should not belong to the category of stand-alone.

Verification by a committee towards the fulfillment of the conditions mentioned above and the continued fulfillment of the requirements for the above mentioned course(s) as per the norms and standards of AICTE and the laboratory requirements as per the curricula and syllabi of Anna University for the above courses.
